# VIII Guest Speakers: 2:15-3:05

# Congressman Jerry McNerney – Topic: "Impressions of the January 6<sup>th</sup> Insurrection and Current Legislative Efforts Moving Forward"

At the time of the insurrection, Congressman McNerney was in his office across the street from the west side of the capital. He watched what was happening from his office and was in his office for many hours. He was instructed to have his gas mask ready, stay away from windows and lock doors. In speaking with his colleagues that were there, many are suffering PTSD because they were within arm's length of these insurrections. The insurrections meant business and if anyone had been captured they could have been harmed or killed. No assistance came for hours. Some of his colleagues were sheltering in a small room with republicans who refused to wear a mask (super spreader event). By about 9-10 p.m. the capital was cleared and they were called back to vote on the electoral college results. Five people were killed and approximately 100 were injured.

Congressman McNerney penned a letter to the DOJ in which approximately 20 of his colleagues cosigned. The letter demanded that the same standards be applied against the insurrectionists that they intended to apply against the BLM protestors which were mostly peaceful across the country. The DOJ had sent out harsh guidelines for prosecuting BLM protestors.

What is happening now in the House of Representatives: The American Rescue Plan was passed. HR1 (For the People Act) was passed to ensure voting rights, to do campaign finance reform, end gerrymandering and eliminate foreign influence in our election. A background checks bill was passed that would require background checks expansion for all weapon purchases. A bill was passed to protect violence against women and the equity plan. They extended the timeline for passage of the ERA so that it can be included in the constitution.

Congressman McNerney wrote a letter along with Anna Eshoo from Palo Alto to the cable, satellite and streaming services to ask them to explain how they can perpetuate disinformation on channels such as Fox News. How can they do that without having some responsibility for the problems that this misinformation, lies and conspiracy theories can cause. This can inflict real harm to people and our democracy. These organizations that disseminate this misinformation have to bear some responsibility.

Moving forward: Our focus is on infrastructure (transportation, water, broadband, airline and electrical infrastructure). This will create jobs and prosperity in this country. We want republican support but will move forward even without their support. We will be moving aggressively on climate. We need to reduce and eliminate carbon emissions in as short a time as possible. We need to include technology to suck carbon out of the atmosphere. He is working on privacy – How can we make sure that artificial intelligence doesn't create more damage than the good things it is going to produce. We have challenges because the Republicans are running a scorched earth policy and will try to block what we are trying to accomplish. We need to be fired up to make sure we don't lose any seats in the 2022 midterm elections. He will have a challenge because this district is becoming more republican.

# JoeEly/Shirley Shelangowski (3-5 minutes) "Ballot Disclosure Act

coastline. One from gas leasing and the other promoting pollution protection. BART is looking at addressing mental health calls on their trains and homeless issue. Bentwood City Council voted down Bridlegate development proposed by Seeno. This is the second housing development outside the city general plan that has been voted down. Annette Lewis and other members of the County Board of Education are doing a great job of putting together a new school board in Oakley. Other schools in the district are working on getting students back in school through a hybrid model. Dr. Lamon Frances from the Delta Bay Church of Christ held a news conference to speak out against the East County Today blog run by Mike Burkholder that has resulted in death threats against Antioch Mayor Lamar Thorpe, Vice Mayor Monica Wilson and Council member Tamisha Walker. East Contra Costa Dems Deborah Vincent was a panelist for the NAACP East County Covid Forum. East Contra Costa Fire Protection completed phase 1 of the consolidation process with ConFire, phase 2 should start in April.
